In continuation of this Ministry's letter of even number dated 12.05.2017 and your letter No. DrMKSMCRC/MCl/30/17 dated 24.05.2017 furnishing required undertaking & Bank Guarantee, I am directed to convey the formal permission of the Central Government for establishment of new Medical College at at Ahmedabad, Gujarat in name & Style of Dr. M K Shah Medical College and Research Centre with annual intake of 150 MBBS students for the academic year 2017-18 under Section 10 A of the IMC Act, 1956.

- 2. This permission of the Central Government is accorded initially for a period of one year and will be renewed on yearly basis subject to verification of achievement of annual targets as indicated in your scheme. This process of renewal of permission will continue till such time the infrastructure and expansion of hospital facilities are completed as per norms of Medical Council of India. The next batch of students shall be admitted only after obtaining permission of the Central Government.
- Admissions made in violation of the above conditions will be treated as irregular and action under IMC Act, 1956 & Regulations made thereunder will be initiated.
- 4. The Government Medical Colleges (except those located in J&K, Andhra Pradesh & Telangana States) shall contribute 15% of MBBS seats for which the LoP is granted for all India quota.
- Discrepancies, if any, may be brought to the notice of MCI and Central Government.
